Disciplinary Action

I understand that if I do not abide by all School District Policies, local law and traffic ordinances, I am subject to losing parking privileges. In addition, detention, suspension, towing (at vehicle owners expense), or ticketing may occur.

I understand that if a situation arises that the Administration and Local Law enforcement have the right to search my vehicle.
